I, {full legal name} Deputy Reuben Marty, in my position as {job title} Deputy Sheriff with the {name of law enforcement officer/agency} Volusia Sheriff's Office, swear and affirm that the following facts are true and correct.

1. {Name of Respondent} ██████████ ██████████ poses a significant danger of causing personal injury to himself/herself or others by having a firearm or any ammunition in his/her custody or control or by purchasing, possessing or receiving a firearm or any ammunition. The following specific statements, actions, or facts give rise to a reasonable fear of significant dangerous acts by the respondent:

Upon arrival Deputy Agosto made contact with ██████████ ██████████ (V1) who was standing just outside of his home in the front yard. ██████████ immediately notified Deputy Agosto that he was carrying a firearm in his waist band. For officer safety reasons Deputy Agosto temporarily removed the firearm from ██████████'s person. ██████████ advised he was involved in an argument with his girl friend ██████████ ██████████ (W1),

2. {Name of Witness} ██████████ ██████████ provided the following information based on his/her personal knowledge:

Deputies then made contact with ██████████ whose story corroborated with ██████████'s, however added details of ██████████ being suicidal. ██████████ advised while in the bedroom with ██████████ he told her to sit on the edge of the bed which she agreed to. ██████████ then advised ██████████ pulled up a chair and sat directly in front of her where he began questioning their relationship. ██████████ stated ██████████ then removed his firearm
