The following specific statements, actions, or facts give rise to a reasonable fear of significant dangerous acts by the respondent:

On 07/07/2021, at approximately 1305 hours, Deputy Maxwell responded to [REDACTED], Ormond Beach, in reference to a suicidal person. Upon arrival, Deputy Maxwell made contact with [REDACTED] (R1), who was parked on the side of the roadway near the residence. According to [REDACTED] she was the attending nurse for [REDACTED] (V1), while he was on Hospice care due to him having


