[REDACTED] (VI) started banging on his bedroom window and asking him to come inside and talk. [REDACTED] told [REDACTED] to leave the property which resulted in [REDACTED] becoming upset. [REDACTED] refused to leave the property and called [REDACTED] on his cell phone. [REDACTED] answered at which point [REDACTED] began screaming at him and advised [REDACTED] she wanted to harm herself. [REDACTED] additionally told [REDACTED] if she had a gun, she would shoot herself, then hung up the phone. [REDACTED] mentioned to deputies that [REDACTED] (W1) was present for the entire incident. [REDACTED] completed a sworn written statement detailing the incident.

Deputies made contact with [REDACTED] who explained this was the second night in a row that [REDACTED] had come to the residence uninvited, banging on the door and making threats to harm herself to [REDACTED] [REDACTED] completed a sworn written statement detailing the incident.

Deputies made contact with [REDACTED] outside the residence [REDACTED], Deltona who denied making any statements of wanting to harm herself. [REDACTED] was upset because [REDACTED] had cheated on her in the past which ultimately resulted in the end of their relationship. [REDACTED] also owed her money which he had failed to pay her back. [REDACTED] advised deputies that she does not own any firearms nor does she own a CCW.

Due to the statements provided, Deputy Baldwin believed without care or treatment [REDACTED] could cause substantial harm to herself and was placed under the custody of the Baker Act. [REDACTED] was then transported to Stewart Marchman Act located in Daytona Beach without incident.


