who stated the following ██████ and her live in boyfriend, ██████ (D1) got into a verbal argument around 0530 inside of the living room regarding ██████ hiding ██████ firearms in the house. During the argument, ██████ stated he was going to "shoot her and kill her family". Because of the statement, ██████ hid a shotgun as well as a black revolver in the house, out of fear for her safety as well as her family's. Due to this, ██████ grew angry and found his firearms within the residence, arming himself with a shotgun in his left hand and a black revolver in his right hand. During the argument inside the living room, ██████ brandished and pointed the firearms at ██████ several times, saying she "better leave before I shoot you". ██████ left out of fear, and began to walk to her vehicle in the driveway when she heard a gunshot go off behind her on the front porch, approximately 10 yards away. ██████ looked behind her and observed ██████ to be standing on the front porch of residence, and pointing the revolver towards the trees to the right of the residence. ██████ then immediately called 9-1-1 and stood outside until law enforcement arrival.

While speaking to ██████ Deputy Fowler noticed that she was scared, as well as nervous to speak to law enforcement. ██████ advised that the Sheriff's Office was at the residence earlier in the morning in reference to a disturbance, which was all verbal.

While speaking with ██████ she stated she had the entire argument and shooting on audio recording. ██████ played the recording for both Deputy Fowler and Deputy King to listen to (See BWC). During the recording, you can hear the couple argue and scream at each other. Toward the end of the recording, ██████ picks up an unknown object, scaring ██████ Before the recording finishes, a loud bang is heard, resembling a gun shot. Deputies recognized the voices from the recording to be ██████ and ██████ ██████ stated she did not want to send the recording to either deputies, and did not want to press charges or cooperate with the investigation out of fear for the safety of her family, as well as her own.

Deputy Fowler made contact with ██████ who stated the both of them were only in a verbal argument, nothing else. ██████ denied all accusations of holding, pointing and shooting of any firearms. After informing ██████ of his constitutional rights, ██████ elected to only answer questions with an attorney present.

Deputy Fowler observed ██████ to be agitated while speaking to him.

While on scene, Deputy Fowler conducted a neighborhood canvass in regards to if anyone heard a gunshot. Deputy Fowler spoke with both residents ██████ and ██████, who both stated they heard a single gunshot around 0600- 0615 hours, which corresponds with the CAD call (#P211190438)

of the weapons complaint. Neither neighbors had surveillance cameras to capture the incident. While searching around the front porch, Deputy Fowler located 3 rifle shell casings in which appeared older by the color as well as being pushed into the ground, but no handgun shell casings. Upon entering the residence to place ██████ under arrest, deputies observed a rifle laying in the living room, being consistent with the statement given by ██████ of the argument occurring in the living room, as well ██████ pointing the firearm at her. Deputy Fowler confiscated both a black pistol style AR-15 (bearing S/N: DTI-S134980) with a 90 round "drum" magazine located in the living room, as well as a silver .380 handgun magazine located on the kitchen table, adjacent to the living room door. It should be noted ██████ has more firearms inside of the residence that could not be located.
