On 05-21-2021 at approximately 1817 hours, Deputy Jones responded to ██████████ in reference to a suicidal subject. Upon arrival, Deputy Jones made contact with the reporting party, ██████████ (R1) who advised her father, ██████████ (V1), was intoxicated and making suicidal statements. ██████████ further stated ██████████ told her he wanted to put a bullet in his brain and he would also burn the house down with her inside. ██████████ advised ██████████ did not possess any firearms and there was no firearms in the above residence. ██████████ completed a written sworn statement.

Deputy Jones made contact with ██████████ and attempted to talk with him however ██████████ refused to cooperate with and was subsequently placed in handcuffs.

Based upon ██████████'s statements and ██████████ not dispelling Deputy Jones alarm, Deputy Jones concluded there was substantial likelihood without care or treatment ██████████ would cause harm to himself or others in the near future. ██████████ was placed under a law enforcement baker act and transported to Halifax Hospital in Daytona.

Deputy Jones will be completing a Risk Protection Order in reference to Brian.

It should be noted ██████████ had recently been a respondent of another Risk Protection Order under Volusia County Court case number 2020-10399MHDL which had recently expired.
