1. *{Name of Respondent}* _____ poses a significant danger of causing personal injury to himself/herself or others by having a firearm or any ammunition in his/her custody or control or by purchasing, possessing or receiving a firearm or any ammunition. The following specific statements, actions, or facts give rise to a reasonable fear of significant dangerous acts by the respondent:

On 6/11/2022 at approximately 0304 hours, Deputy Campbell and additional deputies responded to _____ Deltona in reference to a fight with a firearm involved. Upon arrival, deputies made contact with _____ (D1) who was armed with a firearm in front of the residence. _____ was disarmed without incident and detained in handcuffs for further investigation. _____ stated that he had armed himself with the handgun in an effort to break up a physical

disturbance between his live in girlfriend, [REDACTED] (D2) and her brother, [REDACTED] (V1) who also resides at the residence.

Deputies then contacted [REDACTED] who stated she was involved with a physical disturbance with [REDACTED] over him interjecting himself in personal conversations between [REDACTED] and [REDACTED]. The disturbance began as a heated verbal exchange between the two, and subsequently became physical. [REDACTED] was determined to be the primary aggressor and was subsequently arrested for battery(DV) .

Deputies conducted an interview with [REDACTED]. [REDACTED] stated he was involved in a verbal altercation with [REDACTED]. During the altercation [REDACTED] struck him multiple times. She also forcibly entered his bedroom by beating the door with a hammer. [REDACTED] exited the bedroom and sat down on the living room couch with his friend, [REDACTED] (W1). [REDACTED] stated he and [REDACTED] were still involved in a verbal altercation when [REDACTED] entered the living room. [REDACTED] pointed a handgun towards him, and demanded [REDACTED] vacate the residence. [REDACTED] stated he then called 911. When asked, [REDACTED] said he was in fear for his life due to [REDACTED] having the firearm in his hand, readily available to use. [REDACTED] stated he wished to pursue criminal charges.

[REDACTED] informed deputies she witnessed the altercation between [REDACTED] and [REDACTED]. She advised while inside of [REDACTED] bedroom [REDACTED] used a hammer to force entry and strike him, tearing his shirt. She and [REDACTED] left the room and sat down in the living room. While in the living room [REDACTED] and [REDACTED] continued to argue. [REDACTED] then entered the living armed with a handgun and demanded they all leave the home.

Deputies determined probable cause existed to arrest [REDACTED] for aggravated assault with a weapon without intent to kill and placed him under arrest 0412 hours.

The firearm [REDACTED] was in possession of was collected and placed into the District 4 Evidence Locker as evidence.
