It should be noted prior to reading this report, ██████ and ██████ are in a romantic relationship and have one child in common. ██████ is also 20 weeks pregnant with ██████ child, which he has knowledge of.

On Friday, February 11th, 2022, at approximately 2150 hours, Deputy Bacon responded to ██████ ██████████, Deltona, in reference to a reported disturbance. Prior to arrival, Volusia Central Communications advised the male involved was holding the baby in one hand and a gun in the other. Upon arrival, Deputy Bacon made contact with ██████████ (D1) and ██████████ (V1), in front of the residence. After removing a black Glock handgun from ██████'s right pocket, Deputy Bacon made contact with ██████ who advised the following:

██████ stated he and ██████ were in the bathroom together having an argument reference taxes. ██████ advised ██████ was cleaning baby bottles in the sink while he was sitting on the toilet. ██████ advised the argument escalated when ██████ punched him in the face without being provoked. ██████ advised he then exited the bathroom and grabbed their child, ██████████ (O1) from the crib and eventually made their way out of the residence. ██████ advised he then placed ██████ in the front seat of his vehicle before taking diapers and other child care products from the back seat and placing them on the ground. ██████ then went around to the driver side of his vehicle in an attempt to leave but ██████ opened the passenger door where ██████ was sitting and sat down. ██████ advised ██████ continued stating he wasn't taking ██████ ██████ then continued to argue with ██████ until Deputy Bacon arrived. ██████ completed a sworn written statement detailing what occurred.

During the course of the incident, Deputy Bacon determined [REDACTED] did strike [REDACTED] in self defense to escape from the bathroom. However, [REDACTED] was found to be the primary aggressor which caused the incident to become physical by forcing [REDACTED] to remain in the bathroom using himself as a physical barrier and physical force by shoving her. Deputy Bacon determined probable cause exists and placed [REDACTED] under arrest for aggravated assault, false imprisonment, and unlicensed carrying of a concealed firearm. While placing [REDACTED] under arrest, [REDACTED] tensed his arms to refused to place his hands behind his back. [REDACTED] was again ordered to place his hands behind his back, to which he demanded to know why he was being arrested. [REDACTED] was then forcibly placed in handcuffs and placed in a patrol car. Based on the above stated information, Deputy Bacon determined probable cause exists to also charge [REDACTED] with resisting without violence. Deputy Bacon subsequently transported [REDACTED] to the Volusia County Branch jail.

During this incident and investigation, Deputy Bacon determined [REDACTED] was never in any immediate danger as a result of [REDACTED] or [REDACTED] actions. Deputy Bacon observed no injury to [REDACTED] who appeared to be in good health.

Due to the incident involving a firearm, Deputy Bacon completed risk protection order on [REDACTED] and submitted his Glock handgun into the Volusia Sheriff's Office District 4 evidence locker for evidence.

Due to the involvement of a juvenile, Deputy Bacon forwarded a copy of this report to the Department of Children and Families and the Director of the Volusia Sheriff's Office Juvenile Services, Carla Quann, for review.
